Audit as requested at 2014 report was found to be not required under Fair Trading rules More expensive than anticipated (approximately \$400 per year audited). The decision was taken to not proceed with the audit given the cost and small number of transactions.

President's Report 2015:

2015 was a very busy year for the association with planning maters and responses to developments and draft plans taking up the majority of the Association's efforts.

DCP Submission

Thank you to Peter Hudson for his ongoing support in the detailed maters of planning policy and for crafting the association's submission to the City Wide Development Control Plan. It is that detailed work that ensures we have a framework in place minimise unsustainable development.

Bridge and path update

The infrastructure coordinator has been in constant communications with council staff about the status of the bride installation. Advertisements for tenders for the installation of the Bridge have gone in the paper this week. The requirement for the tender is that the bridge is installed by April 2015.

During the course of the last 12 months a number of members and other community volunteers, with the financial and material support of council worked to scrap and lay a crushed metal path from Bendalong road to the creek. That work was paused awaiting the installation of the bridge. The path has already been subject to erosion from heavy rains.

The Association now has to consider ongoing fundraising to support the sealing of this path.

NOTE: Councillor Patricia White provided an update on the current status. A number of questions were taken from the membership.

Kylor Update

Following up from the work the Association did in surveying the community and putting forward an alternative plan for the site, council supported the Association's position. Kylor sort a review of that decision from the state government's planning gateway. The decision did not oppose Kylor's proposal but made clear potential future difficulties for a development application. Consequently Kylor decided not to proceed to the Joint Regional Planning Panel and have indicated to council that they wish to proceed with Council's amended plan.

This decision was communicated to the association late last year, however at this point, Kylor does not appear to have proceeded by providing the required plans.

The Association is in regular contact with Council about this mater and will be informed if Kylor decides to proceed.

North Bendalong Headland Redevelopment Update

As many will know, a development application has been lodged for the redevelopment of the North Bendalong Headland.

The Association engaged actively with the proponent prior to the application being lodged and made a submission. I know many individual member of the Association also made submissions.

Red Head Villages established a subcommittee to develop out position and received quite a lot of feedback from members about how to respond to the proposal - particularly in regards to the plans to exceed the height limits for that area. The proposal is for 10 cabins 7.5metre high, when height limits are 6m. The Association argued strongly during the LEP consultation for a 5.5m limit and the councillors during that process, and after much debate accepted a 6m limit with a view to any buildings being single story.

We recognised the development proposal as a significant improvement on what is currently on the site. It has a smaller footprint and will have a number of positive environmental elements in the design including significant revegetation, however we opposed a relaxation of the 6m limit as we think it would set a precedent that would allow other developers to seek to exceed height limits in the future.

The council contacted me only yesterday to ask to arrange a community information session in mid February. The dates are still being worked out with the Hall Committee. Red Head did offer the council last year the opportunity to use this meeting for an information session given the number of residents

Thank you to the committee

I would like to thank the entire committee this year for their ongoing work. Again, like the last few years it was focused on reactive responses to planning policies and developments. I think I speak for most on the committee and hopefully many of the members when I say we are looking forward to a year ahead that can focus on fundraising and lobbying for infrastructure like finishing and sealing the walking track and supporting social events in the community or other community projects.

Business Arising:

Lake Conjola Dredging Proposal

- Council were hoping to provide a presentation at this meeting, however were not available on the long weekend. They have provided an update that includes general information, a timeline and associated maps. - The current plan is:
 - o Environmental assessment to be completed mid year.
 - O Dredging proposed to start Sept November.
 - o Sand to be dried close to boat ramp on Cunjurong Lake shoreline.
 - O Sand to be trucked to Mollymook or sold.
- **Gary Barton** attended the information session at Milton regarding the dredging proposal. He outlined concerns about the number of truck movements per day on local roads, disturbance to residents and sand being blown by prevailing westerly winds.
- Clr Patricia White Consultants have been appointed to prepare an environmental assessment. Noted that the public meeting at Milton poorly attended. 10,000 cubic metre of sand are proposed to be removed. There will be a council briefing at the end of February. Suggestion that consultants also be invited to speak to RHVA. In response to questions:
 - O Any money from sales of sand would go back to the State Government. There may be avenues for council to request this goes back into natural resource management across the LGA.

There was support for another invitation to be extended to council and the consultants to make a presentation to the community either at the next meeting or at a special information meeting.

Action: Justin to contact council and consultants to organise a community briefing on the dredging proposal.

General Business:

Nth Bendalong Headland Development

Dealt with in President's AGM report. Submission on website. Community meeting will probably be held on 18th February in Yulunga Hall.

Skatepark and tree removal

Construction of the facility has gone to tender (notice in Ulladulla Times) Three trees have been removed from the playground area of Yulunga Reserve due to termite damage after a council tree audit. Council paid for removal.

Cycleway/walkway

Dealt with in President's report for the AGM. Bridge has been constructed and tenders are being called for construction.

Community Noticeboard

Presentation by Lorraine Larri regarding the design of a community notice board to be placed at corner of Inyadda Drive and Bendalong Road. Larri and Simon Bartlett have designed the board. Approval has been given by council to erect board beside the RFS board. The board will include contact information for local interest groups. There was a suggestion that there be a statement on the sign along the following lines: "This community values our natural environment".

\$1500 - \$2000 has been allocated for the sign and the proposal is in line with this budget.

There was additional suggestions from the meeting that additional signage be considered in relation to littering, dumping, illegal trail bike riding. It was also raised that the RMS sign at intersection of highway and Bendalong Road is covered in stickers and difficult to read.

Action. Write to RMS in relation to the sign.

Action. Larri and Simon to finalise design and liaise with committee about construction and installation.

Porters Creek Dam

Strengthening of dam wall has been delayed due to ecological studies required. The earliest commencement of project will be spring 2015.
